Approval of Minutes: Motion to approve October minutes Jamie Randall. Second Justina Hautamaki.
MAPS Superintendent Report: Handout for Bond Proposal for consideration Tuesday May 3, 2016 for informational purposes only. Millage rates do not increase. Existing millage on Cherry Creek and Superior Hills has decreased to .58 from 2.5 mil. Blended new mil will go to .58 and will be paid off at the end of 2019 with a little bit more for the new bond. Basically consolidating two debts. This is the biggest thing working on right now. A lot of good meetings and data has taken place to anticipate these needs. Our scores are strong so we do not need any wholesale changes...no major curriculum changes...in a position to look for only little tweeks. Feel we are doing a lot right.

Maps School Board Report: School board also has been working on the bond proposal.
President report: Student has recommended transition class for Seniors instead of $9^{\text {th }}$ graders. Conversation included talk of getting $9^{\text {th }}$ graders into a good start and build relationships for success in school at a pivotal time. Interesting talking point about revisiting those life-topics at the Senior year as they are making another transition.
Also, bond proposal is very important. Still sorting through different scenarios to be sure money is spent correctly.

## School reports:

Alternative high School: no representative, no report.
High School: Today 8th grade orientation... $8^{\text {th }}$ graders visit the High school and students are signing up for classes.

Bothwell: Fundraiser in March. March 1 Box Tops. Kung Fu Panda III family outing is not going to go. Sports Plex not as much of an option. Might be family night in March. Second dance made $\$ 2000$ to purchase restaurant booths for gym lobby area....now fully funded....Four sixseat booths should be installed soon. Booths were roughly $\$ 900$ each with shipping.
