Dear MAPS students, families, staff and community members,

August is here and with it comes the renewed excitement for another school year. Late summer in the U.P. is precious, so please enjoy these last few days before school resumes.

As our students enjoy summer vacation, there is a group of dedicated professionals who have worked tirelessly to ensure our buildings and grounds are ready for your return. Our custodians and other support staff have been busy cleaning our buildings, maintaining our grounds, fixing equipment, and addressing the myriad needs of our complex infrastructure. These hard-working professionals deserve so much credit for their work while our students are away from school.

We recently wrapped up another successful summer enrichment program. Roughly three hundred K-8 students had the opportunity to engage in a diverse and robust learning environment full of enriching activities, including free meals, all at no cost to our families. My greatest appreciation to the administration, teachers, support staff, food service, custodians, bus drivers, and other staff who made this program possible.

It is truly an honor to continue serving alongside so many outstanding professionals at Marquette Area Public Schools. We continue to bring new and exciting programming to all district levels, starting with our implementation of Multi-Tiered Systems of Support (MTSS), an initiative designed to address the needs of all of our students with respect to their academic, social, emotional, and behavioral learning. Our focus this year will be Collective Efficacy, the shared belief that through our collective efforts educators can increase achievement for all students.

Safety continues to be our first priority at MAPS. Thanks to our partnership with NMU, soon there will be over 100 new security cameras installed throughout our district, including additional cameras for every building - some of which previously had none.

In other news, we have made a major investment in transportation and I am very pleased to inform our families that we will soon have five new or slightly used buses incorporated into our bus fleet. In regards to facilities, there are multiple projects underway as our buildings and grounds receive many needed improvements. Projects include renovated entrances and a significantly upgraded elevator at Graveraet, an HVAC unit replacement at Bothwell, a freshly painted bus garage with new windows, improvements to our stormwater drainage systems throughout our facilities, stairway replacement at central office, and a variety of upgrades to our heating, mechanical and electrical systems.

Lastly, I am absolutely thrilled to announce that this year Marquette Area Public Schools will receive the funding to provide every student free breakfast and lunch. This is great news! The future remains bright for MAPS as we prepare to open our doors for the 2023-2024 school year. I am proud to be part of this amazing community and look forward to partnering with you to chart the course for our continued success.

Required Childhood Immunizations for **Michigan Schools**

Schools communicable disease rules are the minimum standard for preventing disease outbreak. Michigan law requires that each student possess a certificate of immunization at the time of registration (or no later than the first day of school) for entry into kindergarten, 7th grade, or into a new school district involving grades 1-12. A child who fails to meet immunization requirements shall not be admitted to school.

DIPTHERIA, TETANUS & PERTUSSIS

Ages 4-6: 4 doses of DTP or DTaP, one dose must be on or after 4 years of age.

Ages 7-18, including all 7th grade students: 4 doses of D and T **OR** 3 doses if #1 given on or after first birthday. 1 dose of Tdap for children 11 years of age or older upon entry into 7th grade or higher.

POLIO

Ages 4-6: 4 doses of polio. Only 3 doses of polio are required if dose 3 is administered on or after the fourth birth-

Ages 7-18: 4 doses of polio. Only 3 doses of polio are required if dose 3 is administered on or after the fourth birthday.

MEASLES, MUMPS & RUBELLA*

Ages 4-6: Two doses are required. The 1st dose must be given on or after 12 months of age. The 2nd dose must be given at least 28 days from the 1st dose.

Ages 7-18: Two doses are required. The 1st dose must be given on or after 12 months of age. The 2nd dose must be given at least 28 days from the 1st dose.

HEPATITIS B*

Ages 4-6: Three doses are required. **Ages 7-18:** Three doses are required.

MENINGOCOCCAL

Ages 4-6: None

Ages 7-18: One dose for children 11 years of age or older upon entry into 7th grade or higher.

VARICELLA (CHICKEN POX)*

Ages 4-18: Two doses of varicella vaccine at or after 12 months of age OR current lab immunity OR reliable history of varicella disease.

Please refer questions to your child's school office or to the school nurse's office at 906-225-5354.

Immunizations may be obtained from your family health care provider or the Marquette County Health Department.

- *Current laboratory evidence of immunity is acceptable instead of immunization with antigen.
- ** All doses of vaccines must be given with appropriate spacing between doses and at appropriate ages to be considered valid.

Food Service Information

We have partnered with Nutrislice to bring a menu format to our parents and students. This partnership provides nutritional information on each item. The Nutrislice menu can be found on the food service tab on our website at www.mapsnet.org. Nutritious breakfasts and lunches are available to all students in the Marguette Area Public Schools. Milk is available to students who bring lunch from home and will be charged at the regular ala carte pricing. The district uses a pre-pay family account, utilizing a student PIN to make purchases. This system can be accessed through MAPS' mobile app or on the district's website where you can make payments, track purchases and receive balance notices.

2023-2024 Meal Prices:

Breakfast – Offered to elementary, middle, and high school students at no cost to the family. We offer a healthy variety of breakfast options. All juices are 100% fruit juice. Cereals and breakfast bars are whole

Lunch – Offered to elementary, middle, and high school students at no cost to the family.

Free and Reduced Meals – Please complete the free and reduced application. This will help the district with funding and assist your students with additional programs available throughout the district. Concussions and Athletic Activities

To provide for the safety of student athletes, all athletic programs of the District shall comply with

the concussion protocols of the Michigan High School Athletic Association, or the protocols which shall meet the requirements of state law and the Department of Community Health guidelines regarding

concussion awareness training and protection for youth athletes (MAPS Policy 5340.01). Educational Materials for Parents and Students are available on our website at https://www.mapsnet.org/ district departments/athletics. All parents and athletes

must acknowledge in writing (in accordance with PA 342 and 343 of 2012) that they have received and reviewed the Concussion Fact Sheet for Parents and/ or the Concussion Fact Sheet for Students prior to Athletic Participation for the 2023-24 school year. School Board Meetings

MAPS Board of Education meetings are generally held at the Marquette Senior High School Library, 1203 W. Fair Avenue. Board meeting agendas, minutes, and open meeting notices, including board committee meeting schedules, are posted on the MAPS website: http://www.mapsnet.org. The Regular Board Meetings for the remainder of 2023 are scheduled for the following dates: **September 18, October 16, November 27,** and **December 18 (all at MSHS)**. All board meetings are held at 5:30 p.m. Special Board Meetings are called as necessary. Board of Education Meetings for 2024 will be scheduled by the Board at the January 8, 2024 Reorganizational Meeting. All board meetings provide an opportunity for members of the public to comment.

Policy for Emergency Use of Seclusion and Restraint

In December of 2016, the State of Michigan adopted new laws restricting the use of seclusion and restraint in public schools with the intent to provide a uniform policy that accomplishes certain objectives. Notice to Parents Regarding Title I

In accordance with the requirement of Federal law, for each school receiving Title I funds, the Superintendent shall make sure that all parents of students in that school are notified that they may request, and the Board will provide the following information on the student's classroom teachers:

- whether the teacher(s) have met the State qualification and licensing criteria for the grade levels and subject areas they are teaching
- whether the teacher(s) is teaching under any emergency or provisional status in which the State requirements have been waived
- the undergraduate major of the teacher(s) and the area of study and any certificates for any graduate degrees earned
- the qualifications of any paraprofessionals providing services to their child(ren)

In addition, the parents shall be provided:

- information on the level of achievement of their child(ren) on the required State academic assessments
- timely notice if the student is assigned to a teacher who is not "highly qualified" as required or if the student is taught for more than four (4) weeks by a teacher who is not highly qualified.

This applies to students attending Graveraet, Cherry Creek, Sandy Knoll and Superior Hills. Please contact Superintendent Zack Sedgwick at 906-225-4200 to request any of this information.

Tobacco-free schools

Smoking and the personal use of tobacco products is prohibited twenty-four (24) hours a day, seven (7) days a week on school grounds, District owned or leased vehicles and property controlled by the District. MAPS Board Policy 7434.



Notice to Parents Regarding Instruction in Reproductive Health

The Board of Education has established a program of instruction, which includes HIV/AIDS and other serious communicable disease prevention education and sexuality education. HIV/AIDS, other serious communicable disease prevention education and sexuality education (high school level) are offered in identified courses as components of reproductive health education program.

According to Michigan law, you have the right to review the materials and curriculum content to be used in HIV and other serious communicable disease prevention education, as well as sex education. The local board of education, in compliance with the statute, has made the materials and curriculum guides available for your review. If you wish to review the materials or curriculum content, please contact your child's school to arrange a time for your review. You also have the right to observe instruction in your child's classroom. If you wish to do this, please call your child's school to make arrangements.

This statute allows you to excuse your child from participation in the classes that include HIV and other serious communicable disease prevention instruction, as well as sex education, if you so choose. You will be notified by your child's school when these classes will be taught. If you wish to exercise your right to excuse your child from instruction without penalty, please send written notice to the school principal and course instructor.

Wellness Policy

The Board recognizes that good nutrition and regular physical activity affect the health and well-being of the District's students. Furthermore, research concludes that there is a positive correlation between a student's health and wellbeing and his/her ability to learn. Moreover, schools can play an important role in the developmental process by which students establish their health and nutrition habits by providing nutritious meals and snacks through the schools' meal programs, by supporting the development of good eating habits, and by promoting increased physical activity both in and out of school. The Board, however, believes this effort to support the students' development of healthy behaviors and habits with regard to eating and exercise cannot be accomplished by the schools alone. It will be necessary for not only the staff, but also parents and the public at large to be involved in a community-wide effort to promote, support, and model such healthy behaviors and habits. The Board has set goals in an effort to enable students to establish good health and nutrition habits. See Policy 8510 -Wellness.

Notice regarding Student Privacy and Consent / Opt-Out

The Protection of Pupil Rights Amendment (PPRA), 20 USC§1232h, requests the Marquette Area Public Schools to obtain consent or allow you to opt your child out of participating in certain school activities, including a student survey, analysis, or evaluation in an applicable program that concerns one or more of the following eight areas (Protected Information Surveys):

- Political affiliations or beliefs of the student or student's parent.
 Mental or psychological problems of the student or student's
- Mental or psychological problems of the student or student's family.
- Sexual behavior or attitudes.
- 4. Illegal, antisocial, self-incriminating, or demeaning behavior.
- Critical appraisals of others with whom respondents have close family relationships.
- 6. Legally recognized privileged relationships, such as with lawyers, physicians, or ministers.
- Religious practices, affiliations, or beliefs of the student or parent / quardian.
- 8. Income, other than as required by law to determine program eligibility or financial assistance.

This opt-out right also applies to the collection, disclosure, or use of student information for marketing purposes (marketing surveys) and to certain physical exams and screenings. For further information or to submit a request, contact Superintendent Zack Sedgwick, 906-225-4200.

School Busing

If you have signed up for busing by completing the Transportation Request Google form, bus stop/time information will be available via the Here Comes the Bus (HCTB) mobile/web app and/or your Skyward Family Access account. The Transportation Request Google form, HCTB app information and a link to your Skyward Family Access account can all be found on the MAPS website (mapsnet.org) under Parent Resources. Please contact the Transportation Office for your student ID number necessary to create your HCTB account. The student ID number is also printed on the student boarding card. Please check the HCTB app or Skyward Family Access on a regular basis, as bus schedules update nightly. If your transportation needs change, parents and guardians should complete a new Transportation Request form, however, please be aware that it may take some time to accommodate changes in busing.

Notice Regarding School Board Policy on Drug-Free Schools

In accordance with Board Policy 5530 and Federal law, the Board of Education prohibits the use, possession, concealment or distribution of drugs by students on school grounds, in school or school-approved vehicles, or at any school-related event. Drugs include any alcoholic beverage, anabolic steroid, dangerous controlled substance as defined by state statute (including prescription drugs) or substance that could be considered a look-alike controlled substance. Compliance with this policy is mandatory for all students. Any student who violates this policy will be subject to disciplinary action, in accordance with due process and as specified in the student handbooks, up to and including expulsion from school. When required by state law, the District will also notify law enforcement officials.

The District is concerned about any student who is a victim of alcohol or drug abuse and will facilitate the process by which he or she receives help through programs and services available in the community. Students and their parents should contact the school principal or counseling office whenever such help is needed.

Notification Regarding Inspection of Instructional Materials

Parents have the right to inspect, upon request, any instructional material used as part of the educational curriculum of the student. The parent will have access to the instructional material within a reasonable period of time after the request is received by the building principal. The term instructional material means instructional content that is provided to a student, regardless of its format, including printed and representational materials, audiovisual materials, and materials in electronic or digital formats (such as materials accessible through the Internet). The term does not include academic tests or assessments.
